NEW FRAGMENTS OF CASUALTY LISTS

(PLATE 73)

THE following are two new fragments of fifth-century casualty lists which join already-published pieces found in the Athenian Agora. The numbers continue those of inscriptions from the Agora published in this volume of *Hesperia*.

2 (Plate 73). Fragment of Pentelic marble, found December 1, 1967, in a modern house-wall south of the western end of South Stoa II (K 16). Rough-picked back preserved; otherwise broken.

Height, 0.32 m.; width, 0.26 m.; thickness, 0.185 m.

Height of letters: 0.014 m.

Inv. No. I 953 f.

This piece joins at the top with Agora I 953 d, at the bottom with Agora I 953 c, both of which came from the debris of the Excavation House (cf. *Hesperia*, XXXIII, 1964, No. 2, pp. 18-20, pl. 1 = S.E.G., XXI, 120). I give below the combined texts to line 2 of Frag. c.

- Line 1. Only 0.005 m. to the left of the tau in line 10 there appears at the break a slanting stroke with a spot above it. This can be restored only as a four-barred sigma, even though that letter has three bars elsewhere in this inscription, or as a mu written vertically. In either case it must be part of an added name. Examples of both possibilities are known: in I.G., I^2 , 929, dated 460, a four-barred sigma is used in the addition in line 67; on I.G., I^2 , 928, dated 464, names were added vertically in lines 39, 40, 133, 134.
- Line 5. The third extant letter is either lambda or kappa, more probably the latter, as there seem to be traces of the upper branch at the break. The only root which comes to mind, with either letter, is the Lydian Tmolos, hardly likely at Athens. Nor is it clear whether or not the name ended with the nu; there is in the next space a nick which may be the base of an iota.
- Line 15. The only known Athenian name which fits here is Eumareides (*P.A.* 5808-5810). However, the appearance of three hitherto unknown names (Schoinokles, Choron, and Xenokreon) seems to make the restoration hazardous.

The joining of these fragments makes necessary a reappraisal of Agora I 953 b (S.E.G., X, 409), which at the top was re-cut on a slant matching that on the bottom of Agora I 953 c and which also seemed to be the top of a column. In Hesperia, XXXIII, 1964, p. 20, it was suggested that b therefore stood two columns to the right of c. However, the extension upward of the column represented on c now makes this impossible; to continue the line of the cut until b was the top of a column would make the stele impossibly wide. A re-examination of b revealed that the vacat at the top was an illusion caused by the angle of the cut. A name with four letters could have stood above the first extant line, and there does exist, in the right position in the fourth letter-space, a spot of color which could be the lower right angle of a nu; this was first noticed by D. R. Laing and can be seen in the photograph in Hesperia, XXXIII, 1964, plate 1. The line above that could have contained a name with up to seven letters. It is difficult to ascertain just where b belongs. It is possible that the nu at the top is in the same line with the delta in the last line of c, giving the name Dion. But a join there is not certain; there was disagreement among epigraphists whom I consulted. If b does not belong there, it most probably came from an adjacent column. This seems more likely than that it came from below, with at least one whole letter-space lost in the re-cutting. It is still not clear how large a monument is represented here, although it seems probable that all the fragments we have came from one stele, cut up for building purposes.

3 (Plate 73). Fragment of Pentelic marble, found in the Roman Agora in 1965; now in the Mosque there. Rough-picked back and left side with anathyrosis preserved; broken elsewhere.

Height, 0.30 m.; width, 0.263 m.; thickness, 0.145 m. Height of letters, ca. 0.009 m. Inv. No. Roman Agora, 1965, 20.

At the bottom this fragment joins Agora I 1008c (Raubitschek, *Hesperia*, XII, 1943, No. 8, Frag. I, pp. 39-41 = S.E.G., X, 424), lines 4 and 5 of which are included in the second column of the text above. A re-examination of this stone shows that the first extant letter in line 4 is delta. The join also indicates that only seven letters, not eight, preceded the first extant epsilon in line 1.

R.A. 20, therefore, belongs, as Frag. N, to the public funeral monument which I have elsewhere dated to 409 B.C.; see *Hesperia*, XXXIII, 1964, No. 15, pp. 43-55 = S.E.G., XXI, 131. Its thickness, anathyrosis, and column width of 14 letter-spaces all show that it belongs to the first and second columns of the third stele, which are the ninth and tenth of the whole monument. The join makes it necessary to move

Frag. I one column to the left of where it was placed in *Hesperia*, XXXIII, 1964, p. 47. The table there should now read as follows:

Third Stele

Col. IX, Aiantis. Width of 14 letter-spaces. Frags. N, Col. I, and I, Col. I.

Col. X, Antiochis. Width uncertain. Frags. N, Col. II, and I, Col. II.

Col. XI, Foreigners (?). Width of 15 letter-spaces. Frag. H, Col. I.

Col. XII, Athenians listed by all phylai. Width uncertain. Frag. H, Col. II.

It is, of course, not absolutely certain that Frag. H does not belong in Cols. X and XI. Two considerations, however, make this unlikely. First, the column containing all the phylai should normally be the last; cf. *I.G.*, I², 950. Secondly, the horizontal checker-pattern on Frag. H measures *ca.* 0.0111 m., slightly less than the 0.0115 m. in Col. X and the 0.012 m. in Col. IX.
